**Invitation to Bid**

Notice is hereby given that the Artesia Board of Education is seeking sealed bids for Cafeteria Food, Supplies, Fruit & Vegetables. Bids may be obtained by contacting Clinton H. Taylor at [ctaylor@bulldogs.org](mailto:ctaylor@bulldogs.org) or by visiting the school districts website [www.bulldogs.org/Business\\_Services](http://www.bulldogs.org/Business_Services). Bids will be received by the Artesia Public Schools at the Administration Office, 301 Bulldog Boulevard, Artesia, New Mexico on or before May 30, 2024 at 3:00 PM local time at which time the bids will be opened and read aloud. Bids received after 3:00 PM will be marked "nonresponsive" and returned to the Offeror unopened.

Bids should be sealed in an opaque envelope bearing the name of the vendor and marked: **Cafeteria Food, Supplies or Fruit & Vegetables Bid 2024-2025.**

**Instructions to Bidders**

All bids shall be submitted on the form as issued by the Artesia Public Schools, and same shall be filled out for the items the bidder wishes to bid on. Nutrition Facts Sheets and Product Specifications are required to be submitted with the proposal sheet. Changes or alterations to the form(s) will automatically cause the bid to be rejected.

**General Terms and Conditions**

The Artesia Public Schools reserves the right to reject any or all bids, including without limitation, the rights to reject any or all nonconforming, non-responsive, unbalanced or conditional bids and to reject the bid of any bidder if owner believes that would not be in the best interest of the Artesia Public Schools to make an award to bidder, whether because the bid is not responsible or the bidder is unqualified or of doubtful financial ability or fails to meet any other pertinent standard or criteria established by the owner.

The New Mexico Procurement Code, Sections 13-1-28 through 13-1-199 NMSA 1978, imposes civil and misdemeanor penalties for its violation. In addition, the New Mexico criminal statutes impose felony penalties for bribes, gratuities and kick-backs.

Pursuant to 13-1-135 NMSA 1978 and NMAC 1.4.1.65, the Artesia Public Schools chief procurement officer, Clinton H. Taylor, is conducting this procurement on behalf of Artesia Public Schools as well as the Lake Arthur Municipal Schools and therefore grants the Lake Arthur Municipal Schools permission to purchase items off of the published bid tab for the 2024-2025 school year. Vendors must agree to this condition.

Except as may be otherwise provided by this document, the awarded contract may be terminated in whole or in part by either party to the awarded contract in the event of failure by the other party to fulfill its obligations under the awarded contract through no fault of the terminating party; provided that no such termination may be implemented unless and until the other party is given:

a.at least thirty (30) days written notice (delivered by certified mail, return receipt requested) of intent to terminate, and

b. an opportunity for consultation with the terminating party, followed by a reasonable opportunity, of not more than ten (10) business days or such other reasonable amount of time as may be required under the circumstances, to rectify the defects in products or performance, prior to termination.

The SFA may terminate an award prior to the expiration of the term, without cause and without penalty, upon thirty (30) days written notice to the selected Vendor.

The Vendor certifies that neither the Vendor or its principals; the sub-recipients or their principals; or the subcontractors or their principals are suspended, debarred, proposed for debarment, voluntarily excluded from covered transactions, or otherwise disqualified by any federal department or agency from doing business with the Federal government pursuant to Executive Orders 12549 and 12689. The Vendor specifically covenants that neither the Vendor nor its principals; the subcontractors or their principals; nor the sub-recipients or their principals are included on the Excluded Parties List System ("EPLS") maintained by the General Services Administration ("GSA"). By responding to this solicitation the Vendor is certifying they are in "Good Standing".

The Byrd Anti-Lobbying Amendment requires a lobbying certification to be obtained for procurement contracts of more than \$100,000. Any vendor whose contract award is for more than \$100,000 must complete a Certification Regarding Lobbying form. The SFA must keep this signed certification statement on file with a copy of the vendor's contract.

**Products and Services Specifications**

1. Bid prices shall be effective **August 1, 2024, through July 31, 2025**. If at any time during these effective dates, winning vendor provides written notification to Artesia Public Schools that it can no longer honor the bid prices, the Artesia Public Schools will reject the new price and select another vendor for the specified items.
2. Items ordered by Artesia Public Schools must be delivered to Artesia Junior High School, Fifteenth and Cannon Ave., Artesia, New Mexico, no later than 2:30 P.M. on the days delivered.
3. Bidder shall indicate BRAND of product on every item on where brand item is listed as "Specify".
4. Bidder must provide nutritional facts with his bid, which will include product specifications and list of ingredients.
5. If possible, bidder should bid on the item count as specified.
6. Artesia Public Schools will not be charged a fuel surcharge for delivery of ordered items. If bidder cannot agree to this contract term, the bid will be rejected and returned to the bidder.

7. The Artesia Public Schools participates in the National School Lunch Program and School Breakfast Program and is required to use the nonprofit food service funds, to the maximum extent practicable, to buy domestic commodities or products for Program meals. A 'domestic commodity or product' is defined as one that is either produced in the U.S. or is processed in the U.S. substantially using agricultural commodities that are produced in the U.S. as provided in 7 CFR 210.21(d).

**Evaluation Criteria and Award**

In evaluating bids, owner will consider the qualifications of bidders, compliance with the prescribed bid requirements, bid price and other data, as may be requested in the bid documents. Bid will be awarded to the lowest responsive bidder on each item.

Mr. Aaron Caldera, Food Service Manager, will begin placing his orders with the awarded vendors on August 1<sup>st</sup>, 2024. The first day of school is expected to be August 8, 2024.
